


- i) **As per Prasar Bharati Circular dated 14.05.2007 that those officers including UOT case who do not move to their places of posting/transfer within a period of 15 days, they would be stand relieved from the Kendra after the expiry of 15 days from the date of issue of order or the expiry of 15 days from the date, they have been transferred as mentioned in above order.**
- ii) Only in UOT cases if any incumbent has joined Kendra as per previous transfer order, the change in place of posting as per as per this order will not be effective and previous transfer order will stand as it was.
- iii) Head of Difficult Kendra would ensure that incumbents posted at these Kendra are relieved as per this order only if they have physically completed the tenure as per rule.
