

- i) As per Prasar Bharati Circular dated 14.05.2007 those incumbents (including UOT cases) who do not move to their place of posting/transfer within a period of 15 days in respect of transfer with immediate effect, they would be stand relieved from the Kendra after the expiry of 15 days from the date of issue of order.
