The tenders will be opened by the Board of Officers of Doordarshan on 20-07-2009 at 15:00 hrs in the room of undersigned in the presence of such tenderers or their representatives who may choose to attend. The rates quoted by the successful tenderer will be valid for a period of one year from the date of tender come in force. Director, Delhi Doordarshan Kendra, Delhi has a right to call fresh tenders any time during this period.

3. Copy of Bank Statement showing the yearly turnover of the firm for the two financial year.
