**Subject: Requirement of funds under Salary on account of MACP-reg.**

Reference is invited to this Secretariat's letter of even number dated 11<sup>th</sup> June, 2010 vide which the quarterly requirement of funds to be released in a particular quarter has been called for with a view to contain the budget crises.

2. In spite of the above enhanced requirement under Salary apparently on account of payment of salary arrear caused by upgradation of Pay under MACP scheme is being indicated by the Stations/Kendras. While giving MACP arrear Stations/Kendras should have been allowed for payment after the receipt of additional budget from Prasar Bharati Secretariat. It is not known to B&A Wing of Prasar Bharati Secretariat as to whether the Stations/Kendras have incorporated the requirement on this account in their regular budget for the year 2010-11 and as to how the shortage of funds are suddenly coming up now. However, this has severely affected the regular salary payment at several Stations/Kendras and Prasar Bharati has been receiving a series of requests from various Stations/Kendras for enhanced Cash release.

3. In order to overcome the above situation, both the Directorates are requested to immediately work out the requirement of budget in this regard Stations/ Kendra-wise and forward the same to this Sectt. expeditiously for considering it separately and release budget / cash accordingly. The Stations/Kendras may kindly be advised to make the payment to the Officers and Officials who got the benefit of pay hike under MACP scheme only on receipt of budget from Prasar Bharati, in case they have not kept any budget out of SBG 2010-11 for the purpose.

4. Further, from the month of July onwards, Prasar Bharati has sent the funds in two Bank Account-Salary and Other Administrative Expenses. However, it has also come to the notice that Stations/Kendras have not got issued cheque Book for the second bank Account, therefore directions may be given immediately to take up the matter with the Bank for necessary action.
